**Reckless Imprudence Resulting in Physical Injuries and Damage to Properties**  
(Vehicular Accident)

On March 10, 2023 at about 5:30 PM, a vehicular accident transpired along Nueva Ecija – Aurora Road, Brgy. Pangatian, Cabanatuan City, wherein following parties indicated below were involved and assisted by personnel of Sector 9;

**Vehicle 1** – Yamaha Xmax motorcycle, color yellow/black, with temporary plate no. 888WAD, driven by **RUSTICO CRUZ JR y MANALASTAS**, 53 years old, married, government employee, resident of Rosemar Village, Brgy. Carmen, Zaragoza, Nueva Ecija, no driver's license presented and

**Vehicle 2** – Honda TMX motorized tricycle, color red, with plate no. CN6821, driven by **EZEKIEL TIPAYAN y KILAONG**, 57 years old, married, farmer, resident of Brgy. Bagong Buhay, Cabanatuan City, no driver's license presented, with passenger identified as **BELEN DEL ROSARIO Y LAMIÑA**, 61 years old, married, resident of Brgy. Sapang Buho, Paialayan City, Nueva Ecija.

**Facts of the case:**

Information received by this Station revealed that V1 was travelling heading West while V2 was running towards opposite direction(East). Upon reaching the place of incident, both vehicles accidentally collided with each other while V2 was on the process of turning left going to Turbo Oil gasoline Station. As a result, V1 driver and the occupants of V2 sustained injuries and were brought to Dr. PJGMRMC for treatment. Likewise, involved vehicles have incurred respective damages of still unestimated amounts.

On this time and date, one **TESSIE CAYANGA CRUZ**, wife of V1 driver had personally appeared to this Station and presented the Death Certificate of his husband (V1 driver) who died on March 11, 2023 while undergoing medical treatment at Dr. Gloria D.
