**INCIDENT/EVENT:**

On June 18, 2023 at about 4:54 in the afternoon, a road crash incident related to rear end collision transpired along SLEX vicinity of San Pedro City, Laguna towards north direction the incident were assisted and reported to this office by SLEX Patroller R. Velayo with office address located at Km-44 Sitio, Latian Brgy. Mapagong Calamba City Laguna.

Initial investigation appears base on interview to responding SLEX Patrol and alleged statements of drivers that both vehicles involved were traversing the stretch of South Luzon Expressway occupying lane 1, upon reaching the place of occurrence, leading Veh-1 described as **(Mitsubishi Mirage/ Sedan)** the driver was gradually traversing the said place due to traffic congestion when queuing Veh-2 marked as **(Toyota Wigo/ Hatchback)** upon notice of sudden decrease in speed of vehicle ahead, the driver immediately applied precautionary brake to avoid collision yet, failed to stop quickly enough and hit/bumped the rear portion of Veh-1 by front portion of his driven vehicle subsequently incurred undetermined damages on both vehicles involved.

In connection with; both drivers agreed that incurred damages of Veh-1 will be shouldered by the driver of Veh-2 thru insurance provider as stated in writing. Failure to settle the compromise agreement, this case is subject to escalate to proper court.

**ACTION TAKEN:** Evaluate the point of collision, damage portion and statement of driver/possessor; likewise check the existence of registration and license.

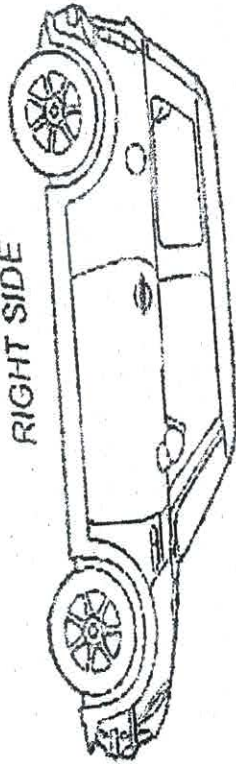

**SKETCH OF VEHICLE DAMAGES**

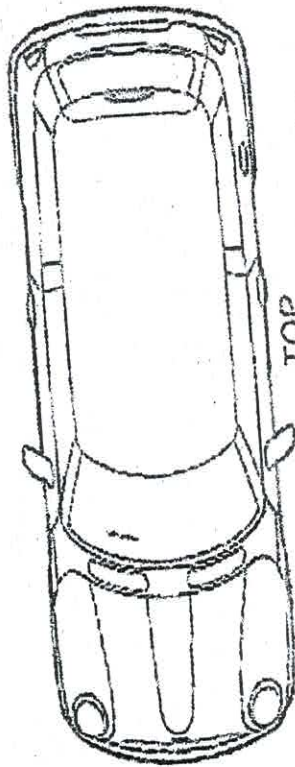

**SKETCH OF VEHICLE DAMAGE/S**

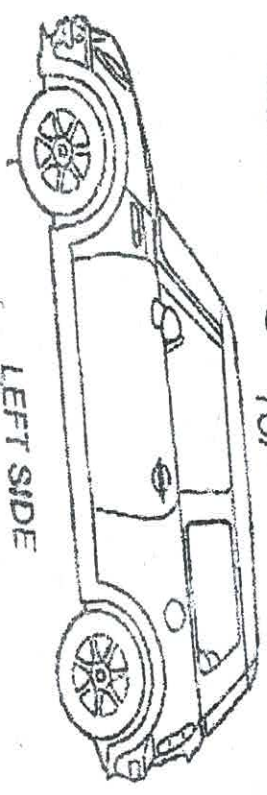

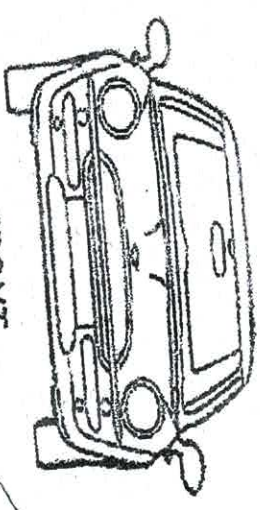

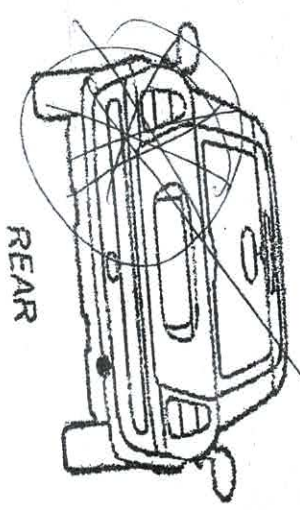
